BAYHILL PREMIER CUP

PLAY-OFFS RULES: 2019-2020

1. The play-offs will be played in two (2) stages or as the organizing committee finds it necessary:
 - a. Preliminary stage.
 - b. Round Robin stage
2. All players born in the years between **2000** will be eligible to play in the play-off stages during **2019 only**.
3. In the continuation of the play-offs, which will take place during 2020, players born in the years between **2001 will be eligible to play**.
4. All players must be in possession of a Valid **SAFA** or **SAFA CT** player's registration card for the current year. **SAB, ABC Motsepe, FIRST DIVISION, and PSL** cards will be allowed.
 - 4.1 All players must have a Department of Home Affairs (DHA) issued ID card, or computerized temporary ID document. Or, a valid passport available for purpose of registration and identification.
 - 4.2 If a player is not able to produce proof of identification, such a player will be deemed to be ineligible and will not be allowed to participate in the play-offs.
5. Players must be registered for the **2019/2020** season with their participating club.
6. Clubs will be allowed to register twenty (20) players.
 - 6.1. **Guest Players are allowed under the following conditions:**
 - 6.1.1 **Conditions of guest players rule:**
 - The player/s must be registered on the SAFA Cape Town Player Registration System.
 - The club where the said player/s is from has written permission from the said club to participate and may play in the club tournament and is released for the duration of such specific club tournament only.

- A player/s is/are allowed to guest for one (1) team/club per season only.
 - The participating team/club is limited to a maximum of three (3) guest players for a club tournament.
7. All players / teams must be registered with the **Premier Cup Committee before** the end of their first half.
 - 7.1 Should a team fail to register before the end of the first half they will be disqualified.
 8. Any team fielding an ineligible player (not properly registered) **will** be disqualified from the competition.
 9. The preliminary stages will be played on a one (1) match knock-out system.
 10. The team winning the match will proceed to the next stage of the play-offs.
 11. **Should the match end in a draw, a penalty shout-out will take place as per the FIFA rule; five (5) penalties per team.**
 12. Clubs are reminded to be on time for their matches: A grace period of ten (10) minutes allowed should a team arrive late. (**To be ready on the field of play**)
 13. If a team is not ready to play after the grace period allocated, such a club will be deemed to have defaulted. (Team managers are responsible to obtain the times of their fixtures)
 - 13.1 If a team fail to pitch for their match, such a team will be disqualified from the play-offs.
 14. The opponents of the defaulting team will advance to the next stage of the play-offs.
 15. The duration of all matches will be twenty-five (25) minutes each way with no extra time.
 16. Teams will be allowed to use five (5) substitutes per match.
 17. The committee reserves the right to do random checks on any team's player's cards.

18. **Managers are reminded to be present when referees check player's cards.**
19. In the event of a clash of colors, the team mentioned second on the fixture shall affect the chance of strip.
20. **PARTICIPATION FEES**
 - 20.1 Teams shall pay **R100.00** on each day of the play-offs.
 - 20.2 Teams playing from the round robin stage for the first time shall pay **R200.00**
 - 20.3 Gate entry fees are as decided by the Facility Management Committee. (FMC)
21. Clubs are responsible for the behavior of their spectators/ supporters.
22. The committee will not tolerate any misbehavior towards match officials during the competition. The committee has the right to report any misdemeanor by a participating team to the perpetrator's LFA.
23. No Protest will be allowed throughout the Play-offs. Managers are to ask the referee to note any concern on the match sheet. The committee will follow up if requested to do so.
24. The premier Cup committee will only communicate with the registered manager of the team should any concerns arise.
25. The Premier Cup committee and/or the Sponsor shall not be held responsible for any **loss or damage of property, or injuries sustained** during or after the match for the duration of the entire playoffs.

THE PREMIER CUP COMMITTEE RESERVES THE RIGHT TO ARBITRATE ANY MATTER/S NOT COVERED BY THESE RULES.
